Call to Order

Dr. Woody welcomed the group as the ranking officer and asked for introductions for all of those present. A sign in sheet was distributed for each section member to verify their email addresses.

Board Update

Dr. Schmitz has assumed the role of ACEP President and other duties prevented her from attending.

Section Update

Dr. Woody and Mr. McKenzie gave the section update, stressing the need the need to demonstrate value. FEC Section membership has dropped to 107 current members. There was significant discussion about how to demonstrate value and recruit more members to join the Section. If the membership falls below 100 members as of December 31, 2021, the FEC Section will not receive a Councilor for the 2022 Council meeting. The Section will also go on probation to allow a chance to increase membership above 100 again. Failure to do so will result in the Section being dissolved.

He also reviewed the Section Assigned Objectives prompting the following comments:

Do the FEC Section Members find the EngagED Platform to meaningful as a communication tool?

Can National ACEP help the Section with public messaging about FECs?

Two of the seven members present noted that their groups have pursued CIHQ accreditation.

Council Update

Resolution 74: Regulation by State Medical Boards of All Who Engage in Practice of Medicine.

Dr. Chris Kang was elected President-elect and Drs. Tony Cirillo, J.T. Finnell, Rami Khoury, and Heidi Knowles were elected to the Board. Dr. Kelly Gray-Eurom ran unopposed as Speaker with Melissa Costello elected as Vice-Speaker.

Newsletter Update

In Dr. Castro's absence, Dr. Woody updated the section on future newsletters. He called for more participants and topics as well as interesting clinical cases for inclusion in future newsletters.

Action Agenda

There was discussion speaking to how FECs can be viewed by ACEP as an organization. We need to prove that we are real emergency departments and demonstrate a quality practice model. Data will be needed to prove quality care is provided at FECs. it was mentioned that TAFEC is currently conducting a study to obtain that information and that EDPMA lobbies at the federal level for recognition of freestanding emergency centers. It was suggested that NAFEC, TAFEC and ACEP work together to achieve that goal and collect data for advocacy purposes.
