ACEP is launching an Opioid Management Learning Collaborative on E-QUAL, with the support from the Addiction Policy Forum and Yale University. The program will recruit EDs nationwide to:

- Collaborate on opioid-focused interventions
- Develop a best-practice toolkit
- · Collect data on quality
- Assess the state of ED and hospital care
- Study the effectiveness of engaging EDs in quality improvement

The learning collaboration will help EDs implement alternatives to opioids (ALTO), improve opioid prescribing, and adopt harm reduction strategies such as naloxone prescribing and medication assisted therapy.
